OBJECTIVES OF THE CENTER

- To engage faculty in various "Innovation and Entrepreneurship' related activities such as ideation, problem solving, proof of concept development, design thinking, IPRs filing, research project preparation and execution.
- To encourage activities that involves 'innovations' with techno-commercial feasibility in all the disciplines offered by the Acharya Nagarjuna University.
- To provide legal protection to the innovations of the faculty of Acharya Nagarjuna University
- To establish a transparent administration system for the ownership and control of intellectual properties and sharing of the revenues generated and owned by Acharya Nagarjuna University.
- To impart practical training on aspects related to IPs in the form of seminars and conferences and offering diploma and certificate courses.

Mission or Activities of ANU- CIIPR:

- 1. The Intellectual Property Rights (IPs) can be in the form of Patents, Industrial Designs, Trademark, Copyrights, and Geographical Indications that need to be protected against their exploitation for some period of time.
- 2. ANU-CIIPRs creates awareness and offers assistance to academicians, researchers, entrepreneurs and innovators to identify, protect and manage Intellectual Property Rights (IPRs) effectively.
- 3. ANU-CIIPR center processes the innovations by patentability search for the inventions and research proposals, it helps in drafting and filing of patent applications in consultation with IP attorney offices.
- 4. ANU-CITIPRs will be functioning as the nodal center to assist Industries, Entrepreneurs, Universities and Colleges for IPR related matters.
- 5. ANU- CIIPRs will also file applications related to Trademarks, Copyrights and Industrial Designs.
- 6. It will work in coordination with National and International IP organizations like CSIR-IPU, DIPP, NRDC, and WIPO to conduct programs to create awareness on Intellectual Property Rights and conduct Diploma and Certificate Courses.
- 7. ANU- CIIPRs will also help in filing the applications for International Patents through Patent Cooperation Treaty (PCT).
- 8. It will create an 'ANU innovation portal' to highlight innovative projects carried out by our faculty and students.

TERMS AND CONDITIONS

University will provide the financial support up to the maximum of Rs2.00 lakhs

Duration of project: Maximum two years

Process of approval: After thorough scrutiny by the expert committee, Expert committee will recommend the proposal for sanctioning the proposal by the university authorities.

Review: For every six months review of the work will be monitored. After satisfactory performance of the work in the first year, second year budget will be released.

After completion of the project the following items are to be submitted

- 1. Final report both hard and soft copies
- 2. Copy of the patent if published
- 3. Copy of the published papers
- 4. Audited statement of expenditure statement and Utilization certificate

Eligibility: Regular Faculty and Contractual Teaching Faculty are eligible to apply
