## **Instructions to Candidates:**

- 1. Qualification for Medical Officer on contract basis <u>MBBS with 3 years experience of general</u> practice
- 2. <u>Salary:</u> Rs.55,000/- per month for the post of Medical Officer on contract basis as per the G.O.Ms. No.686, Medical & Family Welfare Department, dated 09.11.2020.
- 3. Eligibility:
  - A) candidates should have passed MBBS Degree examination included in the Schedule-1 of the MCI Act, 1956 as amended from time to time and from a college recognized by the Medical Council of India, and completed internship by on or before 01.11.2018.
  - B) Must be registered (on permanent basis) with State Medical Council of Andhra Pradesh
  - C) In case Candidates who studied MBBS in Abroad must have registered (on Permanent basis) with State Medical Council of Andhra Pradesh.
- 4. AGE: The minimum and maximum age shall be reckoned as on 01.11.2021 with relaxations allowed for reckoning duly the maximum age limit as per rules the candidate should not have completed 47 (42+5\*) years of age as on 01.11.2021. (\*Relaxation for S.C. candidates 5 Years).

N.B.: The Format may be downloaded and Filled as per requirements asked for.

Originals: All the originals in respect of educational qualifications, experience, publications and social status must be produced at the time of interview.

- 1. Testimonials: Only copies of testimonials should be enclosed. Such copies will not be returned.
- 2. (a) Applications from candidates who are employed should be sent through proper channel.
  - (b) Doctors already in the employment of the University shall apply for the post advertised by the University, if they wish to be considered.
